Curia begins at 7:27

1. Approval of previous meeting minutes.

Vote: 4 in favour, 0 opposed, 7 abstentions, motion passed

2. Office of the Keeper of the Goldkey – it has been vacant since February 2017. What exactly does the office do, and do we need to fill it?

The Keeper of the Goldkey is responsible for keeping an inventory of the Goldkey, maintaining it in good condition and ensuring that it is available at events. They don't necessarily have to be personally responsible for transporting it, but they should make arrangements for it to get there. The office should not be removed, but the emails should be redirected to the Chatelaine for now. The position should be advertised as vacant and we should try to fill it.

3. Using Google Chat for discussions outside of Curia

Officially, there is no problem with using Google chat to discuss issues outside of Curia. We are allowed to use whatever forum works best for us for discussions. However, any actual voting must occur through the official emails and must include a summary of any discussions that took place prior to voting. Angharad's concern about using Google Chat (or Facebook or any other online forum) for discussion is that it will exclude any officers that are less comfortable with the technology or don't have regular access to a computer. Discussion in person at Curia meetings is still the preferred method for making decisions. It was suggested that we could create documents in Google drive to discuss issues.

4. Archery backstop net replacement – We don't have the budget for it right now, shelved until next Curia after BIA.

5. Alcohol permits for events – we are not allowed to use the Reunion permit for our events because we charge admission. The only way that we can legally serve alcohol at events is to remove the site fee and make the event donation-only, but we are not allowed to suggest a donation amount. Rather than adopting a policy for all events, it will be left up to the autocrat of each event to decide if they will make the event donation-only or have it be dry. It is too late to change BIA to a donation event because registrations have already been accepted so the event will have to be dry. This includes the A&S competition, there can be no submissions by brewers.
6. Location of future Curias. Angharad proposed that all Curias (until further notice) be held at Wesley United on Tuesday evenings rather than alternating between Wesley and the Greene Centre. Wesley is more convenient for a number of reasons.

7. Scheduling a date to organize storage before BIA. Propose date is Tuesday, February 6<sup>th</sup>. Is there anything in EK or Society Law to prevent us from selling/auctioning baronial property? Angharad has gone through Society and EK Law and the Society and EK Financial Policies and there is nothing that prohibits us from selling/auctioning off baronial property as long as it is not done online. Online auctions are prohibited. Also, cash receipts must be provided for any income collected from the sale of goods purchased with group funds.
8. Update on the coronets  
2/3 to ¾ finished. Gaeira is hoping to finish them in time for BIA. If not, they will be finished in time for the May camping events.
9. Update on the SOPs  
Tadea has provided us with a copy of the changes made to the SOPs so far, but the committee has not been able to work on them since May 2017. Additionally, Tadea no longer has the time to head the committee. Leana & Sile have volunteered to take over the committee for updating the SOPs.
10. Recent changes to EK Law regarding officer reporting. It is now a requirement that for all Local Officer reports to Kingdom Officers (or their Regional Deputies), the branch Seneschal must be notified by the local officer that the required report was timely filed.  
Also, all officers must use their officially-provided online account for all business of their office.
11. Unused email addresses. The migration of our email over to Google brought up a number of email addresses that are registered to our group but are not currently being used by anyone. Should these addresses be redirected or deleted?
